Proposed Operating Budget Presented. Motion made & seconded to approve Operating Budget. All in favor.

We are still in need of a volunteer to organize and file our taxes with a CPA. We are also seeking an attorney licensed in Mass to finalize our updated by-laws. Contact us if you are interested.

Doug Moglin -Southwick Select Board member- Also here are Jason Peron and Diane Gale fellow select board members. Working in partnership with the towns of Suffield, and CRC. We recognize that the lake & ecosystem are a critical part of Southwick. The town has proposed to increase funding for weed treatment to address the new invasive hydrilla weed. There are several businesses around the lake reopening soon. We are excited to see them open again.

Colin Moll- Suffield First Selectmen- Update on Babbs. A structural engineer visited the site today. The environmental study will be done next. The town of Suffield moved \$30,000 to cover costs for the studies. It would cost about \$10 million to rebuild as it was. The new proposed Construction should cost under 1.5 mil.

Working on bonding through Suffield for the project later this year. We're excited. We have 6-8 months to go. The government moves slowly. We aim to keep our historical buildings. But also understand that financially there are certain limitations. We hope the plan for Babbs Rink preserves what it is but allows everyone to use the space. The LPP negotiations (a 5-year agreement) for Suffield Residents will be discussed with Southwick & Suffield officials in July.

Hydrilla Found in the lakes. The lakes will need 2nd treatment to address this invasive (non-native)

LPP Reminder – Southwick & Suffield residents. Get your yearly dock and boat stickers- **Violators will be ticketed/fined daily.**

Dredging muck will be done near the south ramp. LMC is looking for federal funding close to \$100,000 for the dredging. If unsuccessful they will apply for CPC funding. Research and funding for other dredging projects are continuing.

Lake buoy update- CRC voted to approve additional funding to light more buoys in the lake. The buoy lights appear to be dim. Checking with Mark to see if they can be brighter.

Scott, Mike, Brian, the Pratt Family, and LMC (and many others) put the north ramp docks every year. CRC approved to purchase of a couple of pairs of waders and neoprene gloves for our volunteers. David Hanson Act- proposed act to require vessel operators to pass boat cert test. Still in process with the state of Massachusetts. No further info at this time.
