Babb's Treasurer Ginny Graves reported on the Babb's Park account balances.

Jerry Crane provided some history and an update on Babb's Park and noted that the 4<sup>th</sup> of July parade had over 50 boats participating.

Janeene Crane announced that the Little Black Dress fundraiser will be held at the Cove on Sunday, October 9, 2016 from noon to 5 p.m. She encouraged men to attend too.

Kevin Maloney encouraged any present who are not yet members to join and passed out several membership forms.

Steve Schmid announced that he will show the movie "Hoot" at Babbs this Friday night if there is no rain.

Dennis Clark and John Whalley of the Southwick Conservatoin Commission discussed efforts to purchase the land on North Pond that has 2700 feet of lake frontage. August 6 is the kick-off of the fund-raising efforts with the Franklin Land Trust. They are working to obtain matching funds from various businesses. Their goal is to obtain \$1 million in contributions from citizens. Massachusetts Fish and Game will also contribute \$1 million. They have one year to raise the necessary funds. They would like a link to their site added to the CRC website. If purchased, Southwick and Fish and Game would own the land which would be open to light recreation.

Ron Greene discussed the issues surrounding the kayak regatta/race and said that he hopes to have these resolved within the next 10 days so that he can move forward with the planning.

Christine Pepka gave a history and update on CLEPO, the appeal of their lawsuit victory, and the successful golf outing on Saturday, July 9, at the Suffield Country Club which raised additional funds. Almost \$50,000 has been raised over the past two years.

Deb mentioned that the weir gates on the stream draining South Pond had been tampered with and asked anyone with information to come forward.
